The Ministry of Digital Development, Innovation and Communications has received financing from the World Bank toward the cost of the Smart Government-2 project and intends to apply part of the proceeds toward payments under the contract for “Supply and installation of servers and networking devices, security hardware and infrastructure equipment for upgrading national data center and disaster recovery center”.
2. The Ministry of Digital Development, Innovation and Communications now invites sealed Bids from eligible Bidders *to supply and install the servers and networking devices, security hardware and infrastructure equipment for upgrading national data center and disaster recovery center to be delivered to the location stated in the Final Destination of “List of Goods and Delivery schedule.*
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers”, September 2023, and is open to all eligible Bidders as defined in the Procurement Regulations.

Only bidders that have purchased an official set of bidding documents will be eligible to submit their bids.

All envelopes marked "SECOND ENVELOPE: FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public opening.
